PROGRAM DETAILS

The Foundation will provide a voucher to each chapter to be awarded to an individual who is ready to apply for an ASIS CPP Certification. The voucher will enable the individual to go online and apply for the CPP at no cost. Each selected recipient will then need to qualify per the certification guidelines in order to take the test and achieve certification.

In order to receive this gift from the Foundation, chapters are encouraged to:

- Set up an ASIS Foundation CPP Accelerator Chapter Committee
 - Should include: chapter officers, designated CPP representative, designated Foundation representative (5-7 ASIS members in good standing is ideal)
- Agree to abide by the ASIS Foundation policies for gift selection through a selection process that is fair, objective, and inclusive
- Create a formal application process (a sample will be provided by the ASIS Foundation)
- Announce and promote the availability of the gift from 1 October – 31 December 2018
- Evaluate applications in January 2019 and select a recipient by 31 January
- Notify the ASIS Foundation of selected recipient and submit their application by 31 January
 - The chapter may determine how the individual will be notified of his/her selection
 - Once notified, the Chapter will also inform the ASIS Foundation

The ASIS Foundation will communicate with selected recipients so that appropriate tax forms can be completed. Once appropriate tax forms have been received, it will take two weeks to provide the exam gift voucher. Winners must use the voucher by 1 April 2019.

Please note that the gift voucher does not guarantee that the recipient will achieve certification. The gift voucher provides the selected recipient with the opportunity to go online and apply for the ASIS CPP certification at no cost.
